## TMs

Use the superscript TM on the first use of the word Decisis™ on the web page or print material. Subsequent uses on the same page do not require the TM symbol. If you have a 2-sided print material (i.e., a postcard), please use the TM on the first use of the word on both sides.

Additionally, the Decisis citator, InterCite™ is also trademarked. The same recommendations apply.

## Language

Marketing materials for Decisis should have a light, friendly tone. This is a new brand, and we speak in a natural, light-hearted, slightly humorous voice. See the appendix for examples.

## Logo

There are 4 versions of the Decisis logo. In full color, we have a horizontal version and a stacked version. In all white, we have the same configurations. Please use the full color version as much as possible, but we understand if you're

using a dark or teal background, an all-white version will look better. If you need something else, please let us know.

We also have the Decisis column by itself in full color. This can be used as a favicon, button, or app icon where the display size is too small for the stacked logo to be legible.
